

# **Friends of Arlington's Great Meadows Annual Report for 2013**

This report recaps the accomplishments of the Friends of Arlington's Great Meadows (FoAGM) in 2013 and an update of happenings during the year. We wish to thank everyone who has helped in one way or another with these efforts.

## **Stewardship Activities**

### **Education and Outreach**

This year we finished and distributed our first decade report reviewing our activities since 2002. We also produced a new guide map for AGM which is posted on the kiosks and available on our website: [www.foagm.org](http://www.foagm.org)

### **Mowing of upland meadows**

Three years ago, we undertook a project to restore the upland "entry meadow" at the northwest corner of AGM, which had been rapidly reverting to woodland, to its historical open condition. The goals of the project, guided by a study performed for AGM by Mass Audubon and approved by the Lexington Conservation Commission, were to preserve the meadow's scenic beauty and to promote diversity of habitat, including that of the American Woodcock.

In the fall of 2010, with the assistance of a large group of volunteers, we cleared the area of trees and dense shrubbery. In the spring of 2011, we planted a mix of native wildflowers in the southwestern corner of the meadow. Since that time, with the help of volunteers, we have worked to control invasives and the re-growth of woody vegetation by hand trimming.

To maintain this lovely meadow, we commenced this year what we anticipate will be an annual or biannual mowing program. The work was scheduled in the early fall to avoid interference with nesting birds and to minimize the impact on wildflowers.

### **Invasive plant control**

We continue our efforts to clear and maintain an approximately 100-yard stretch of AGM along the Minutemen Bikeway that had become densely overgrown with the invasive plant Japanese Knotweed. Permanent eradication of this invasive is extremely difficult, particularly without the use of herbicides. However, over the last ten years, with volunteer labor and purely mechanical means, we have succeeded in keeping this area mostly knotweed-free, preserving a stunning view of the Meadows from the bikeway.

## Financial

Donations to AGM in 2013 were about the same as in 2012. However income exceeded expenses and we continue to hold healthy cash balances. It is satisfying to note that all of our income is from individual donations and employer matches, so we are fully supported by the generosity of our dedicated members and not dependent on municipal budgets, grants, corporate funding, or fundraising events. FoAGM also continues its successful partnership with the Arlington Land Trust (ALT) as fiscal agent.
